ATTENTION EXHIBITORS: NO TRAINING allowed PRIOR to or DURING ratings. All entries must be paid at closing. Bitches in season allowed at to run at end but must be kept away from test area until called. Notify test secretary. Dogs qualifying for a rating are awarded a ribbon and are recommended to WCA for approval and issuance of a certificate. Ratings are official when confirmed by the National Office.

ELIGIBILITY OF DOGS: Read Carefully

- a) Any Weim with an individual AKC number or an ILP number who has obtained the age of 6 months on day of test for any or all ratings offered.
- b) Rating tests are open to all Weim whose owners and co-owners are **members of the WCA**
- c) Spayed bitches/neutered males may compete.
- d) Weimaraners that have disqualifying faults(as listed in the current Standard for the breed) shall be eligible to compete for or receive ratings provided they are spayed or neutered. *Weimaraners with disqualifying faults(as listed in the current standard for the breed) must be certified by the National Office as being spayed or neutered and receive a DQF number PRIOR to being entered in a ratings test.* AKC PAL/ILP numbers are not required to apply to the National Office
